FORMAT: Certified by USBC. Everyone must have a current USBC membership card to participate.

1. AVERAGE TO BE USED:

- A. 2007-2008 Highest Book Average (USBC 319A 10 Pin Rule is in effect)
- B. 2007-2008 Highest End of Season (21 games or more)
- C. 2008-2009 March 1st Average (21 games or more)
- D. 2008 Highest Summer Average

E. Bowlers without an acceptable average will use a 210 scratch average.

Failure to use the correct average shall disqualify score if submitted average is lower than correct average thereby resulting in more handicap. Prize winnings will be based on submitted average if it is higher than correct average, however corrections in averages may be permitted up to the completion of the first game.

2. Handicap: 80% of 210 for men and women.

3. Any bowler winning \$600 or more in any tournament in the last twelve (12) months must report amount and scores to tournament director for possible re-rating. Tournament director reserves the right to re-rate (USBC Rule 319D). If the bowler does not accept the re-rated average, entry fee shall be refunded. Rule 319E is not in effect.

4. Entry deadline 30 minutes before each squad time (Rule 310B);
Multiple entries allowed; however bowlers may cash only once (Rule 315)

5. Qualifying - Saturday, February 28 (maximum 96 bowlers per squad) Prize ratio (1:8)
Squad Times - No Squad Times on Friday Night
Saturday - A - 9:00 am; B - 11:00 noon; C - 1:00 pm; D - 4:00 pm; E - 6:00 pm; F - 8:00 pm
Bowl 3 games, top 96 bowlers advance to semi-finals.

6. Lanes will be assigned for elimination and for semi-finals. (REQUESTS TO BOWL TOGETHER CANNOT BE HONORED)

7. ALL ties (including finals) to be determined by one (1) game roll-off.
IF ROLL-OFF IS NECESSARY TO DETERMINE THE 96 SEMIFINALISTS, IT WILL BEGIN PROMPTLY AT 9:30 AM, SUNDAY, March 1.

8. SEMI-FINALS - Sunday, March 1, 2009 at 10:00 a.m.

9. FINALS - Sunday, March 1, 2009 following semi-finals.
32 bowlers will draw for brackets and bowl 2 game matches.
16 losers eliminated 16 winners bowl 2 game matches
8 losers eliminated 8 winners bowl 2 game matches
4 losers eliminated 4 winners bowl 2 game matches
2 losers eliminated 2 winners bowl 2 game matches for championship
