ELIGIBILITY REQUIREMENTS TO PARTICIPATE IN THE 2012 KEN JAM TEAM AND DOUBLES TOURNAMENT

The following rules, plus USBC rules, will govern all participants in this tournament

1. **MEMBERSHIP:** Must be a current member of USBC of good standing. Entrants must show current membership card when checking in.
2. Entrants averages shall be based upon the following:
 - A) Highest USBC average on Bowl.com from 2010-2011 season.
 - B) If neither of the above, then the highest 2011-2012 fall season average having a minimum of 21 games as of midnight Jan. 14th, 2012.
 - C) If no average available, entrant must bowl scratch with 220.
 - D) All participants should be familiar with USBC rule 319, a-e which will apply. Players having won \$600.00 or more in any event or tournament within the past twelve (12) months must report: actual scores, position and amount won to tournament management prior to bowling in this event.
 - E) Bowlers with re-rated/or have used a re-rated average in a sanctioned tournament within the past twelve (12) months must report this average to the tournament director for possible use in tournament.All averages must be verified. All bowlers are responsible for submitting correct average. Failure to use correct average shall disqualify score if submitted average is lower than actual average, or prize winnings will be based upon submitted higher average. Verification should be provided by your local Association Manager.
3. Handicap will be based on 90% of 220.
4. Multiple participation will be allowed: A team will consist of any combination men and women and may participate once with same the team. Must change 1 person to participate on another team
A doubles team will consist of any combination of men and women and may participate Only once with the same partner
5. Bowlers are responsible for entry fees for doubles. Team captains are responsible for entry fees for teams. NSF/RETURNED checks will void entry & disqualify scores bowled.
6. Prize fee will be returned 100%. Prize ratio will be at least 1 in 6.
7. Tournament Director reserves the right to accept or reject any and all entries and will decide all questions or disputes arising in the tournament. Tournament Directors decision(s) will be final, subject to appeal to USBC. Tournament Director has the right to re-rate any bowler.

All entrants must check-in and substitutions must be made at least 30 minutes before scheduled time.

Deadline: 30 minutes prior to last shift-depending upon lane availability

Premature termination of the tournament at discretion of Tournament Director

If so, prizes to be prorated according to number of entrants who have bowled in each event at the time of termination.
